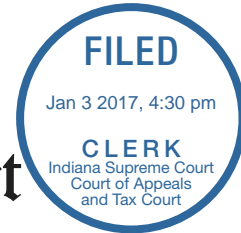

Judges for 2017.

Order

The presiding judges of the courts listed in **Attachment 1** have requested this Court to appoint senior judges to serve in their respective courts, pursuant to Ind. Code 33-23-3-1. We find that these courts have demonstrated a need for senior judge service and that senior judges should be appointed to serve in these courts.

Pursuant to Ind. Code 33-27-4-1, the Indiana Judicial Nominating Commission has certified the persons listed in **Attachment 2** as eligible senior judges for calendar year 2017. We find that all of the certified senior judges should be appointed to each of the requesting courts, in accordance with Administrative Rule 5(B)(1).

IT IS, THEREFORE, ORDERED that each of the certified senior judges listed in **Attachment 2** are hereby appointed to serve in any requesting court listed in **Attachment 1**. The above appointments and authorizations shall remain in effect until December 31, 2017.
